COMMISSION ANNOUNCEMENTS

MEETING/CONFERENCE TRAVEL

Kenneth A. Fogash, Deputy Executive Director, on April 23, released a compilation in connection with travel by Commission members and staff participating in meetings and conferences concerning SEC responsibilities where the Commission accepted payment and reimbursement from non-federal entities. Authority for such payment and reimbursement is granted by the Securities Exchange Act. (Rel. 34-27929)

INVESTMENT COMPANY ACT RELEASES

ALLIED CAPITAL CORPORATION

A notice has been issued giving interested persons until May 15 to request a hearing on an application filed by Allied Capital Corporation II (Allied II), Allied Investment Corporation II, and Allied Financial Corporation (Subsidiaries and collectively with Allied II, Applicants) requesting an order under Sections 6(c), 57(c), 17(b), 17(d) and Rule 17d-1 of the Investment Company Act exempting Applicants from the provisions of Sections 12(d)(1), 17(a), 17(d), 18(a), 19(b), 57(a), and 61(a) of the Act to the extent necessary to permit Allied II (a) to create and own the securities of the Subsidiaries which will operate as licensed small business investment companies, (b) to engage in certain joint transactions involving either or both of the Subsidiaries and conduct co-investments in portfolio companies, (c) to cause the Subsidiaries to pay dividends and make other distributions to Allied II, including long-term capital gains distributions, and (d) to meet modified asset coverage requirements on a consolidated basis with the subsidiaries. PACIFIC HORIZON TAX-EXEMPT MONEY MARKET PORTFOLIO

Notices have been issued giving interested persons until May 21 to request a hearing on applications filed by: PACIFIC HORIZON TAX-EXEMPT MONEY MARKET PORTFOLIO, INC.

and DBL INSTITUTIONAL TRUST for an order, under Section 8(f) of the Investment Company Act, declaring that they have ceased to be investment companies. (Rel. IC-17454 and IC-17455, respectively - Apr. 23)

**SMITH BARNEY MORTGAGE CAPITAL CORP.
SMITH BARNEY MORTGAGE CAPITAL TRUSTS**

A second amended conditional order has been issued on an application filed by SMITH BARNEY MORTGAGE CAPITAL CORP. (Rel. IC-17456) and a third amended conditional order has been issued on an application filed by SMITH BARNEY MORTGAGE CAPITAL TRUSTS (Trusts) and Smith Barney Mortgage Capital Corp. (Rel. IC-17457) (collectively, Applicants), exempting Applicants from all provisions of the Investment Company Act in connection with Smith Barney Mortgage Capital Corp.'s and the Trusts' proposed issuance and sale of bonds principally collateralized by mortgage certificates, sale of beneficial ownership residual interests, and election of REMIC status. The order amends previous orders so that Smith Barney Mortgage Capital Corp. and the Trusts may issue bonds also secured by funding agreements and related notes. (Rel. IC-17456 and IC-17456, respectively - Apr. 24)

HOLDING COMPANY ACT RELEASES

PENNSYLVANIA ELECTRIC COMPANY

A supplemental order has been issued authorizing Pennsylvania Electric Company, an electric public utility subsidiary of General Public Utilities Corporation, to pay additional legal fees aggregating \$64,360 in connection with the issuance and sale through December 31, 1989 of up to \$100 million aggregate principal amount of medium-term securities. LISTING, DELISTING AND UNLISTED TRADING ACTIONS

UNLISTED TRADING GRANTED

An order has been issued granting the application of the Midwest Stock Exchange for unlisted trading privileges in the common stock of two issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

Notices of proposed rule changes have been filed with the Commission by: National Association of Securities Dealers (NASD-90-21) to add a section to Schedule D of the NASD By-Laws establishing a new service called the Digital Interface Service (DIS), which offers market makers an alternative, flexible method of receiving NASDAQ Workstation information and sets service charges for delivery of DIS (Rel. 34-27909);

Cincinnati Stock Exchange (SR-CSE-90-06) to add Rule 11.9(u) and to amend Rule 11.0(1) and (m) in order to modify the Cincinnati Stock Exchange's time priority rules and to permit a market maker to act as Dealer of the day and have priority over same-priced market makers or professional agency interests entered prior in time to his bid or offer when the market maker is interacting with the public agency market and marketable limit orders which he represents as agency (Rel. 34-27910); MBS Clearing Corporation (SR-MBSCC-90-01) to allow MBSCC to collect commissions on behalf of MBSCC-participants acting as brokers (Rel. 34-27922); Options Clearing Corporation (SR-OCC-90-03) relating to the acceptance of late exercises (Rel. 34-27923); and National Securities Clearing Corporation (SR-NSCC-90-05) regarding a proposed expansion of its Dividend Settlement Service (Rel. 34-27926).

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved proposed rule changes filed by: Pacific Stock Exchange (SR-PSE-90-05) to amend PSE Rule II, Section 3(c), to change the confirmation deadline for good until cancelled orders. (Rel. 34-27911)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

Proposed rule changes, immediately effective on filing under Section 19(b)(3)(A) of the Securities Exchange Act, have been filed by: National Association of Securities Dealers (SR-NASD-90-27) to provide a temporary exception for foreign issuers from the NASDAQ/National Market System annual participation fee of \$2,000 (Rel. 34-27921); and (SR-NASD-90-25) to amend Schedule D of the NASD's By-Laws to include a subscriber deposit requirement for certain subscribers of Level 2/3 or NASDAQ Workstation equipment (Rel. 34-27924).

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
